For the purposes of these terms and conditions, Data Protection Legislation means (i) unless and until the General Data Protection Regulations (GDPR) is no longer directly applicable in the UK, the General Data Protection Regulation ((EU) 2016/679) and any national implementing laws, regulations and secondary legislation, as amended or updated from time to time, in the UK and then (ii) any successor legislation to the GDPR or the Data Protection Act 1998.

## Generation Next is a trading name of East Midlands Chamber (Derbyshire, Nottinghamshire, Leicestershire) [hereafter referred to as the Chamber].

b) ensure that it has in place appropriate technical and organisational measures to protect against unauthorised or unlawful processing of Personal Data and against accidental loss or destruction of, or damage to, Personal Data, appropriate to the harm that might result from the unauthorised or unlawful processing or accidental loss, destruction or damage and the nature of the data to be protected, having regard to the state of technological development and the cost of implementing any measures;

c) ensure that all personnel who have access to and/or process Personal Data are obliged to keep the Personal Data confidential;

d) assist the Member, at the Member's cost, in responding to any request from a Data Subject and in ensuring compliance with its obligations under the Data Protection Legislation with respect to security, breach notifications, impact assessments and consultations with supervisory authorities or regulators;

e) notify the Member on becoming aware of a Personal Data breach;

f) at the reasonable written direction of the Member and, so far as it is technically possible to do so, delete or return Personal Data and copies thereof to the Member on termination of the membership unless required by Applicable Law to store the Personal Data; and

g) maintain complete and accurate records and information to demonstrate its compliance with these provisions (a) to (g). The Member acknowledges that the Chamber is reliant on the Member for direction as to the extent to which the Chamber is entitled to use and process the Personal Data. Consequently, the Chamber will not be liable for any claim brought by a data subject arising from any action or omission by the Chamber to the extent that such action or omission resulted directly from the Member's instructions. By taking out a membership with the Chamber, the Member
